Menu Access

To submit or review benefits reimbursement claims for HRA plans (previously referred to as RHS plans), you may access the Benefits Reimbursement link from the participant website.

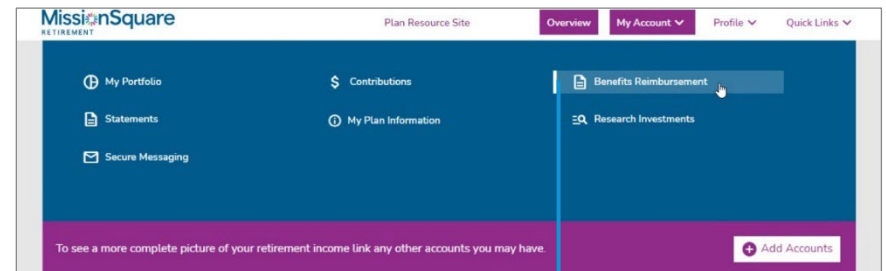
Please note this process will redirect you to the Meritain Health website.

Steps to use with single MissionSquare account

Using the top navigation panel, click on **My Account**, then in the right-side column click on **Benefits Reimbursement**.

My Account > Benefits Reimbursement



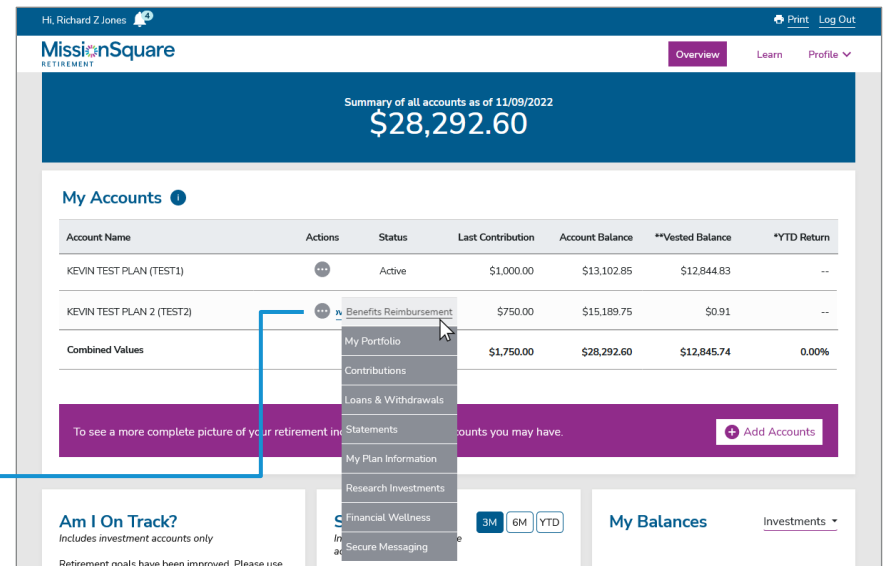
Steps to use with multiple MissionSquare accounts

If you have more than one MissionSquare account, you first need to enter the account pertaining to your claim. Click on the **Overview** button in the top navigation pane, then scroll down to the **My Accounts** tile where your accounts will be displayed.

As transactions are unique to each account, you will need to select the account for this claim type. Simply click on the **Actions** icon (three dots) next to the relevant account name. This will display a pull-down menu.

Select **Benefits Reimbursement** from the pull-down menu. This action will start the process shown on the next page.

Redirect to Meritain Health

The paths outlined on the previous page will load the notification screen shown below. Please note that by continuing, you will be redirected to the Meritain Health website.

Click **OK** to continue.

Meritain Health is the Third Party Administrator (TPA) that exclusively handles all of your Retiree Health Savings (RHS) plan claim processing and record keeping. You will be able to submit your reimbursement requests and inquiries about your RHS claims through the Meritain Health website. Please be advised that clicking "OK" will connect you to the Meritain Health website. As the TPA, Meritain Health complies with the HIPAA (Health Insurance Portability and Accountability Act of 1996) privacy and security rules regarding protected health information of RHS plan participants.

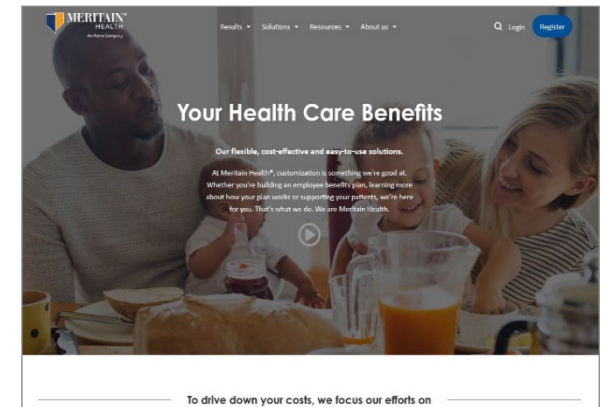

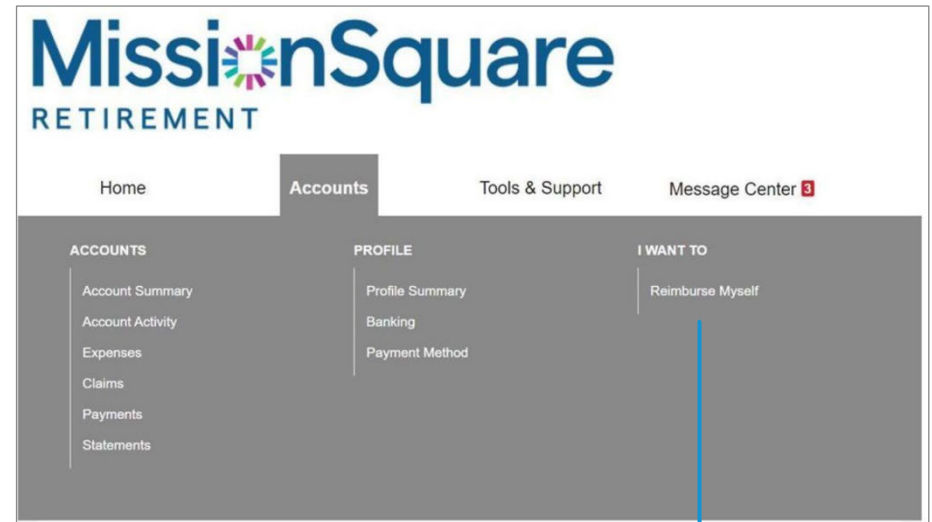
